- (vi) To organise activities for the promotion of physical, mental, spiritual and educational development and upliftment of adults and children without any distinction of easte, creed or religion etc and in the interest of mankind, in general.
- (vii) To aid, establish, takeover or collaborate with any institution or association, having indentical aims and objects as that of the Trust for physical, mental, spiritual, educational development for upliftment of society.
- (viii) To establish any institution or adopt means for promoting any art, science or knowledge in any other field of education, propageting for removal of social evils, customs or for promoting self help to overcome these evils in society.
- (ix) To establish any institution or society for the welfare of victims of natural calamities and to provide food and shelter to needy person from time to time.

5. BOARD OF

- The Board of Trustees shall consist of not less than FIVE and not more (i) than FIFTEEN members.
- The following shall be the First Board of Trustees:

  - Sri Shankar Mahto
  - 5. Sri Indraject Jha.
- (iii) Sri Abhishek Kumar Singh shall be the Managing Trustee and will hold office for life time or until he resigns.
- (iv) In the event of the office of the managing trustee becoming vacant, his wife, sons and daughter or any bodyelse as per his/her will, shall become the managing trustee for life and so on for subsequent successors. In the event of there being no will of the managing trustee, the trustees shall elect the managing trustee from amongst members of the family of the founder managing trustee. If none of the members of the family of the founder managing trustee is willing or available, the trustees shall elect the managing trustee from amongst themselves.
- The Board of Trustees may co-opt perosns if necessary, to raise the total number of members to Fifteen.
- The managing Trustee shall be free to co-opt any person who may be helpful in achieving the objects of the trust as a trustee.
- (vii) A trustee shall cease to hold office of the Trust if the trustee becomes insane or lunatic or insolvent or bankrupt.
- (viii) All other trustees, except Managing Trustee shall hold office for THREE YEARS from the dates of their appointment / nomination and other completion of the terms, their office will autometically become vacated but such trustees can be reappointed / renominated on the expiry of the

- sell, dispose of alienate or otherwise deal with any property of the Trust.
- (g) let out or dispose off an immovable property of the Trust for such period and rent on such terms and conditions as the Trustees in their discretion may think fit.
- open account in the name of the Trust, with a Bank or Banks, to operate such account and to give instructions to the Bank and to provide for opening and operation of such account by one or more of the Trustees or by an agent appointed by the trustees.
- (1) adjust, settle compromise, compound refer to arbitration, all actions, suits claims, demands and proceedings regarding the Trust Fund.
- appoint or make provision for the appointment of any perons (including all or any of the Trustees and committees or administrator or managing Trustees or otherwise) for the purpose of the administration of the Trust in such manner and subject to such rules and regulation as the Trustees choolities to be time copy may prescribe.

- (p) settle all accounts and to compromise, abandon, or refer to arbitration any action or proceedings or disputes, claims, demands or things, as deemed on proper for such propose without being responsible for any loss occasioned thereby.
- (q) borrow money either on the security of any property of the Trust or otherwise for all or any of the purposes of the Trust, and it shall be lawful for the Trustee to make such borrowings on payment of such interest or otherwise on such terms and conditions as they may in their absolute discretion think fit.
- (r) apply to the Government, public bodies, urban, local, municipal, district and other bodies, corporation, companies, or persons for grant of money and of aid, donations, gifts, subscriptions, affiliation and other assistance with a view to promoting the objects of the Trust and to negotiate with the Government Departments, public and other Bodies, corporations, companies or persons, scheme and other works and matters within the objects of the Trust and to accept any proper conditions on which such grants and other payments may be made.

#### 7. FINANCE

- All the activities of the Trust shall be Non Profitable and shall be done on 'No Profit - No Loss' basis.
- The Trustees shall be accountable only for such money and funds which will actually come into their hand.
- (iii) At the beginning the Trust will be run with a Fund of Rs. twenty one thousand only which will be given by Smt. Nivedita Singh W/o Sri Abhishek Kurnar Singh, the managing Trustee, and thereafter with the funds collected through fees and subscriptions from students and other persons who receive benefit from the Institutions run by the Trust.
- (iv) The Trust will accept donation and volunteer contribution in any firm from individual or organization it may accept aid from Government or corporate body or raise fund by borrowing money with or without interest from bank, Financial, Institution or individuals. The borrowed money will be a returned as per the terms and conditions of the loan.
- (v) All the incomes, earnings, movable / immovable properties of the Trust shall be solely utilized and applied towards the promotion of its aims and Objects as set forth hereinabove and no profit thereof shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or in any manner whatsoever to any present or the past member of the Trust or to any other person. No member of the Trust shall have any personal claim on any movable or immovable property of the Trust or make any profit, whatsoever, by virtue of his membership.
- The Trust Fund may be augmented by the income from the initial Fund and also by donations and other contribution from time to time.
- (vii) The Trust Fund shall not be applied to any purpose other than those specified in Article 4 herein above unless the other objects added to the trust objectives.
- (viii) The Fund of the Trust shall be utilized for the maintenance, development and expansion of the Trust and institution run by the Trust. Any immovable property acquired shall be registered in the name of the Trust or institutions -

- The Trustees shall always maintain proper accounts of the Trust, which shall be kept at the office of the Trust. The accounts will be audited once in a year by a qualified Auditor appointed by the Board of Trustees.
- The Financial year of the Trust shall be from April to March.
- The Bank Account of the Trust shall be opened in any scheduled bank at Begusarai to be jointly operated by the Managing Trustee and another member of the Board of Trustees.

### 8. MEETING AND DECISIONS

- (i) The office of the Trust shall be situated at Begusarai or at any other place decided by the Board of trustees.
- (11) The Board of Trustees shall meet at least once in three month either at the Registered office of the Trust or at the residence of any member of the Trust. One third memebrs shall form the quorum. Ordinarily seven clear days notice shall be required for calling a meeting but in exceptional circumstances there may be an emergenct meeting even at one day's notice.
- (iii) All decisions at a meeting of the Board shall be taken by simple majority of the memebrs present and voting at the meeting. However, for amending any provision(s) of the constitution of the Trust, two third number of members present and voting shall be required.

#### 9. CESSATION OF MEMBERSHIP

- Every Trustee will be at liberty to resign from his office by giving one (i) month's notice of his intention to do so.
- A person shall cease to be a Trustee :
- If he/she, without leave of absence, fails to attend three consecutive (a) meetings of the Board of Trustee
- (b) If he is requested to resign by two third number of members of the remianing Trustees.

## 10. DISSOLUTION

If at least two third number of members of the Board of Trustees resolve to dissolve the Trust and get it replaced by another Trust, in a meeting specially called for the purpose, the Trust shall dissolve and be replaced by a substitute. Trust as per the resolution adopted in that special Meeting.




